## VILLAGE BOARD MINUTES OF SEPTEMBER 27, 2010

A REPORT WAS GIVEN ON THE CONDITION OF THE RATHJE MILL AND THE REPAIRS NEEDED. THE HISTORICAL SOCIETY HAS \$5,000.00 AND HAS REQUESTED ADDITIONAL FUNDS FROM THE VILLAGE FOR THE NECESSARY REPAIRS. THE CONSENSUS OF THE BOARD WAS THAT BECAUSE THE VILLAGE IS THE CURRENT OWNER OF THE MILL AND PREVAILING WAGE APPLIES, THE VILLAGE WILL TAKE THE LEAD TO ACCEPT PROPOSALS FOR THE REPAIRS.

PRESIDENT DURAN INFORMED THE BOARD MEMBERS THAT LAST WEEK TIMS, AN INTERNATIONAL MILLWRIGHT ORGANIZATION, WERE ON A TOUR IN THE UNITED STATES AND TOURED THE RATHJE MILL. THEY STATED THAT OUR MILL WAS UNIQUE IN THAT IT IS A GERMAN DESIGN.

ENGINEER KONING INFORMED THE BOARD OF AN EMAIL HE RECEIVED FROM IDOT REQUESTING DOCUMENTS REGARDING COSTS AND FUNDING FOR THE CORNING AVENUE TRAFFIC SIGNAL. THE DOCUMENTS OF ESTIMATED COSTS WILL BE SUBMITTED TO IDOT AND, IF NECESSARY, REDONE TO FINE-TUNE THE FIGURES WHEN IDOT APPROVES THE PROJECT.
