THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. THE SCAVENGER / RECYCLING PROPOSALS WHICH WERE DISCUSSED AT THE LAST BOARD MEETING WERE REVIEWED. THE OPTIONS BEFORE THE BOARD WERE WHICH COMPANY'S PROPOSAL TO ACCEPT AND WHETHER OR NOT TO ADD YARD WASTE. SOME TRUSTEES THOUGHT THE HOMEWOOD PROPOSAL WITHOUT THE YARD WASTE OPTION WOULD BE THE LEAST COSTLY TO THE RESIDENTS. SOME TRUSTEES THOUGHT WE SHOULD LOOK AT ADDING YARD WASTE TO THE CONTRACT IN THE FUTURE AS THE COST OF MAINTAINING THE VILLAGE EQUIPMENT AND DISPOSAL FEES CONTINUE TO RISE.

SCAVENGER / RECYCLING PROPOSALS

MOTION BY FORSYTHE, SECONDED BY REICHERT, TO AUTHORIZE THE VILLAGE PRESIDENT AND VILLAGE ADMINISTRATOR TO MOVE FORWARD WITH THE HOMEWOOD SCAVENGER/RECYCLING CONTRACT NEGOTIATIONS WITH NO YARD WASTE, BUT WITH THE OPTION TO ADD YARD WASTE IN THE FUTURE. FORSYTHE, REICHERT, HUPKE, WICKER, AND CALLAHAN VOTING AYE; MOTION CARRIED.

ORD. 12-26 BOUNDARY AGREEMENT

THE BOARD HAD DISCUSSED BEECHER'S REQUEST TO RENEW THE BOUNDARY AGREEMENT AT AN EARLIER VILLAGE BOARD MEETING. THE CURRENT AGREEMENT WILL EXPIRE IN 2017. THE NEW AGREEMENT WOULD ADD AN ADDITIONAL TWENTY YEARS. THE BORDER OF

CRAWFORD AVENUE WOULD REMAIN THE SAME.

MOTION BY WICKER, SECONDED BY HUPKE, TO ADOPT ORDINANCE 12-26 – AN ORDINANCE AUTHORIZING THE EXECUTION OF A BOUNDARY AGREEMENT WITH THE VILLAGE OF BEECHER, WILL COUNTY, ILLINOIS. WICKER, HUPKE, REICHERT, FORSYTHE, AND CALLAHAN VOTING AYE; MOTION CARRIED.

PERIODICALLY THE ORDINANCES PASSED BY THE VILLAGE BOARD ARE SENT TO AMERICAN LEGAL PUBLISHING WHO CODIFIES THE ORDINANCES AS SUPPLEMENTS FOR THE VILLAGE CODE OF ORDINANCES BOOK. EACH SUPPLEMENT MUST BE ACCEPTED BY AN ORDINANCE IN ORDER TO BE INCLUDED INTO THE CODE BOOK.

ORD. 12-27 2012 S-26 SUPPLEMENT

MOTION BY HUPKE, SECONDED BY WICKER, TO ADOPT ORDINANCE 12-27 – AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES FOR THE VILLAGE OF PEOTONE, ILLINOIS. HUPKE, WICKER, CALLAHAN, FORSYTHE, AND REICHERT VOTING AYE; MOTION CARRIED.

TRUSTEE HUPKE HAS ASKED THAT THE BOARD CONSIDER REVISIONS TO THE FENCE ORDINANCE. THE CHANGES PROPOSED ARE THE HEIGHT REQUIREMENT OF FIVE FEET CHANGED TO SIX FEET, THE SPACE BETWEEN THE SLATS SHOULD BE NO LESS THAN ¼ INCH, NO FENCE SHOULD BE CONSTRUCTED WITH IN FIFTEEN FEET OF A FIRE HYDRANT, EVERY FENCE SHOULD HAVE A GATE AT LEAST THREE FEET WIDE, AND WOOD FENCES SHOULD BE CEDAR OR COMPOSED OF WEATHER AND INSECT RESISTANT LUMBER. THE REASONS GIVEN FOR THE REVISIONS WERE THAT A FIVE FOOT FENCE IS SPECIAL ORDER AT THE BIG BOX STORES AND COSTS MORE, THE ¼ INCH GAP BETWEEN THE SLATS ALLOWS MORE PRIVACY, AND REQUIRING A GATE WOULD BE FOR SAFETY PURPOSES (FIRE, PARAMEDICS, ETC.). TRUSTEE WICKER BROUGHT UP THE PLACEMENT OF THE FENCES AND CORNER LOTS. MOST OF THE FENCE VARIANCES BROUGHT BEFORE THE BOARD CONCERN BRINGING THE FENCE FORWARD FROM THE BACK OF THE HOUSE TO ENCLOSE SERVICE DOORS OR AIR CONDITIONERS. IT WAS SUGGESTED TO GIVE THE RESIDENTS THE OPTION TO LOCATE THE FENCE EVEN WITH THE FRONT OF THE HOUSE OR THE BACK OF THE HOUSE. THE FENCE ORDINANCE REVISION ISSUE WAS REFERRED TO THE BUILDING COMMITTEE.
