SHE STATED THAT THE FENCE WOULD NOT BE VISIBLE FROM THE STREET AND THAT THE NEIGHBORS WERE IN FAVOR OF THE CHAIN LINK FENCE.

CHAIN LINK FENCE VARIANCE 416 N. WEST

PRESIDENT DURAN STATED THAT BECAUSE CHAIN LINK IS NOT ELIGIBLE FOR A VARIANCE THE BOARD MEMBERS NEED TO DECIDE TO REVIEW THE FENCE ORDINANCE AND CHANGE THE ACCEPTABLE FENCING MATERIALS OR KEEP THE ORDINANCE AS IT IS.

TRUSTEE HUPKE INQUIRED IF SHE KNEW THAT THE VINYL COATING WOULD DETERIORATE WITH TIME AND IF SHE HAD LOOKED AT A POWDER COATING WITH A LONGER WARRANTY INSTEAD. SHE SATED THAT SHE HAD NOT LOOKED INTO THAT TYPE OF CHAIN LINK
