CERTIFICATE OF ACHIEVEMEN JACOB PETRUSZAK

THE BONNIE LANE DRAINAGE ISSUE WAS DISCUSSED. THE PUBLIC WORKS COMMITTEE HAD RESEARCHED THE ISSUE. TRUSTEE HACK STATED THAT FOUR PROPERTIES WERE AFFECTED BY STORM WATER. THE SOLUTION TO HELP ALLEVIATE THE STANDING WATER WOULD BE FOR THE VILLAGE TO INSTALL A SIX INCH STORM DRAINAGE PIPE IN THE EASEMENT, WHICH WOULD BE CONNECTED TO THE STORM SEWER, AND THE PROPERTY OWNERS COULD CONNECT THEIR STORM RUN OFF TO THE STORM DRAINAGE PIPE AT THEIR OWN EXPENSE.
