THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE VILLAGE PRESIDENT, STEVEN CROSS, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MR. HUPKE, MR. JONES, MR. BOWDEN, AND MR. HAMM. TRUSTEE MARCH AND TRUSTEE HACK WERE ABSENT. ALSO PRESENT WERE THE CLERK, ADMINISTRATOR, ATTORNEY, ENGINEER, MR. HOFFNER, MS. INGRAM, MS. MIELCARZ, MR. BAUMGARTNER, MS LEXOW, CAITLIN LEXOW, EVIE BUSH, ELIZABETH GRESS, JULIE GRESS, AMY GRESS, AND MR. BILOTTA.

**ROLL CALL** 

MOTION BY HAMM, SECONDED BY BOWDEN, TO APPROVE THE MINUTES OF THE AUGUST 28, 2017, REGULAR VILLAGE BOARD MEETING AS WRITTEN. HUPKE, BOWDEN, HAMM, AND PRESIDENT CROSS VOTING AYE; JONES VOTING PRESENT; MOTION CARRIED.

**MINUTES** 

MOTION BY HUPKE, SECONDED BY JONES, TO APPROVE THE PAYROLL AND TO APPROVE THE ACCOUNTS PAYABLE IN ALL CATEGORIZED FUNDS AS PRESENTED. HUPKE, JONES, BOWDEN, AND HAMM VOTING AYE; MOTION CARRIED.

**PAYROLL & ACCTS. PAYABLE** 

PUBLIC COMMENT - MR. BAUMGARTNER ADDRESSED THE BOARD REGARDING THE POSSIBILITY OF A LIQUOR LICENSE FOR A CAFÉ WITH VIDEO POKER MACHINES IN SUNSET PLAZA. THE CONSENSUS OF THE BOARD WAS THAT WHILE THEY DIDN'T WANT A CAFÉ WITH GAMBLING IN THE DOWNTOWN AREA, THEY WOULD HAVE NO PROBLEM WITH ONE IN SUNSET PLAZA. MR. BAUMGARTNER WILL COMPLETE THE NECESSARY APPLICATION.

**PUBLIC COMMENT** 

POLICE CHIEF REPORT - THE CHIEF INFORMED THE BOARD THAT THE HIGH SCHOOL HAS LOCKED THE GATE ON NORTH STREET AND IS DIRECTING THE SCHOOL TRAFFIC FLOW TO RATHJE ROAD. THE NEW TRAFFIC PATTERN IS WORKING WELL.

REPORTS

ENGINEER REPORT - THE TRAFFIC DATA HAS BEEN GATHERED ON THE I-57 INTERCHANGE AT WILMINGTON ROAD FOR IDOT MEETINGS TO DESIGN A SAFER INTERCHANGE.

BUILDING COMMITTEE - TRUSTEE HUPKE REPORTED ON THE BUILDING COMMITTEE MEETING. THE COMMITTEE DISCUSSED THE CHANGES IN THE FENCE ORDINANCE WHICH INCLUDED REMOVING THE REQUIREMENT FOR SPACE BETWEEN THE FENCE SLATS, CHANGING THE GROUND CLEARANCE TO ONE INCH, AND SETTING THE BUILDING PERMIT FEE AT \$50.00. THE COMMITTEE DISCUSSED INCREASING THE ALLOWABLE SHED SIZE (WHICH WOULD INCLUDE THE CANOPY) AND CONCRETE PADS.

THE BOARD DISCUSSED THE RECOMMENDED CHANGES THAT WERE PROPOSED. AFTER DISCUSSION REGARDING GROUND CLEARANCE, IT WAS DECIDED NOT TO CHANGE THE REQUIRED TWO INCH GROUND CLEARANCE. THE ATTORNEY WILL DRAFT THE ORDINANCE FOR THE CHANGES AND FOR THE UPDATED BUILDING CODES.
