THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE VILLAGE PRESIDENT, STEVEN CROSS, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MR. JONES, DR. MARCH, MR. BOWDEN, MR. HACK, AND MR. HAMM. ALSO PRESENT WERE THE CLERK, ADMINISTRATOR, ATTORNEY, ENGINEER, MS. THOMPSON, MR. BRASHARES, MS. BORMET, MS. MORSE, MS. MAREVKA, MR. JOHNSON, AND MS. SANTORI.

CALL TO ORDER

ROLL CALL

MOTION BY BOWDEN, SECONDED BY JONES, TO APPROVE THE MINUTES OF THE NOVEMBER 27, 2017, REGULAR VILLAGE BOARD MEETING AS WRITTEN. BOWDEN, JONES, MARCH, AND HACK VOTING AYE; HAMM VOTING PRESENT; MOTION CARRIED.

MINUTES

MOTION BY HACK, SECONDED BY HAMM, TO APPROVE THE PAYROLL AND TO APPROVE THE ACCOUNTS PAYABLE IN ALL CATEGORIZED FUNDS AS PRESENTED. JONES, MARCH, BOWDEN, HACK, AND HAMM VOTING AYE; MOTION CARRIED.

PAYROLL & ACCTS. PAYABLE

PUBLIC COMMENT - MR. BRASHARES OF WALNUT STREET, WAS PRESENT TO VOICE HIS CONCERN REGARDING THE PARKING AREA CONSTRUCTION AT TERRY'S FORD. HE STATED THAT IT WAS A SAFETY ISSUE FOR HIS NEIGHBORHOOD. HE INQUIRED IF A BUILDING PERMIT HAD BEEN ISSUED. PRESIDENT CROSS STATED THAT HE HAD SPOKEN TO THE GENERAL MANAGER AND THE ADDITIONAL PARKED CARS WERE GOING TO BE REMOVED BY TONIGHT. THE OATH OF OFFICE WAS ADMINISTERED BY THE VILLAGE CLERK.

PRESIDENT CROSS AND TRUSTEE JONES LEFT THE MEETING.

THE ATTORNEY EXPLAINED THAT PRESIDENT CROSS AND TRUSTEE JONES WOULD NOT BE PRESENT FOR PARTICIPATION IN ANY MATTERS RELATING TO THE DOWNTOWN TIF DISTRICT BECAUSE THEY OWN PROPERTY WITHIN THE DESIGNATED TIF DISTRICT. WRITTEN DISCLOSURES REGARDING THE PROPERTY OWNERSHIP ARE AVAILABLE FROM THE VILLAGE CLERK.

PRESIDENT PRO TEM
