ENGINEER REPORT - PT FERRO CONSTRUCTION WAS AWARDED THE IDOT BID. CLEAN UP HAS BEEN DONE ON THE CORNING AVE. UTILITY WORK. NO NEWS YET REGARDING THE I-57 GUARD RAIL.

MR. BORGO WAS PRESENT TO EXPLAIN THAT HE WOULD LIKE TO RE-SUBDIVIDE THREE LOTS ON WEST STREET INTO TWO LOTS. ONE OF THE LOTS WOULD HAVE THE PREEXISTING APARTMENT BUILDING. HIS INTENTION WOULD BE TO BUILD A SEVEN UNIT APARTMENT BUILDING ON THE SECOND LOT. THE REQUEST TO SUBDIVIDE THE PROPERTY WOULD NEED TO BE REFERRED TO THE PLANNING/ZONING COMMISSION. THE BOARD AND THE ADMINISTRATOR DISCUSSED THE SIZE OF THE PROPOSED BUILDING WHICH WOULD REQUIRE A VARIANCE AND THE INDIVIDUAL OUTSIDE ENTRANCES RATHER THAN ONE OUTSIDE ENTRANCE.

BORGO RE-SUBDIVIDE 451 / 471 WEST ST.

MOTION BY MAREVKA, SECONDED BY MARCH, TO REFER THE PRELIMINARY PLAN OF SUBDIVISION FOR PROPERTY AT 451 AND 471 S. WEST STREET TO THE PLANNING/ZONING COMMISSION.

THE RESOLUTION ASSIGNS AN ADDRESS TO THE FIRE DISTRICT PROPOSED BUILDING ON PEARL DRIVE.

RES. 17-R09 555 PEARL DRIVE

MOTION BY MARCH, SECONDED BY JONES, TO PASS RESOLUTION 17-R09 – A RESOLUTION REQUESTING ASSIGNMENT OF THE ADDRESS OF 555 PEARL DRIVE FOR THE NEW FIRE STATION.

THE ORDINANCE AMENDS TITLE XI, CHAPTER 113 REGARDING RAFFLES. MR. BOLANOWSKI FROM THE PEOTONE AMERICAN LEGION WAS PRESENT TO EXPLAIN THEIR WISH TO BEGIN A QUEEN OF HEARTS LOTTERY AT THE END OF FEBRUARY OR BEGINNING OF MARCH. THE RAFFLE AND THE TRAFFIC/CROWD EXPERIENCED BY OTHER COMMUNITIES WAS DISCUSSED. CHANGES IN TO PROPOSED ORDINANCE REGARDING THE AGGREGATE RETAIL VALUE OF ALL PRIZES AND THE MAXIMUM RETAIL VALUE AWARDED TO \$500,000.00 AND DELETING THE SENTENCE REGARDING THE PERSON WHO ACCOUNTS FOR THE GROSS RECEIPTS AND EXPENSES NOT BEING THE SAME PERSON WHO ACCOUNTS FOR THE OTHER REVENUES OF THE ORGANIZATION.
