MOTION BY MARCH, SECONDED BY JONES, TO GRANT PERMISSION TO THE PEOTONE BOY SCOUT TROUP 315 TO CANVASS THE VILLAGE ON APRIL 23 & 30, 2018, FROM 6:00 – 8:00 P.M. WEST STREET 7 UNIT
APARTMENT BLDG / BORGO

MR. BORGO WAS PRESENT TO SPEAK REGARDING HIS PROPOSED 7 UNIT APARTMENT BUILDING ON WEST STREET AND THE VARIANCES HE SOUGHT THROUGH THE PLANNING AND ZONING COMMISSION. HE STATED THAT THERE WERE ORIGINALLY THREE LOTS AND AN APARTMENT BUILDING WAS BUILT ON ONE LOT, THE DRIVEWAY OF WHICH ENCROACHED ON THE NEXT LOT. HIS REQUEST WAS TO RE-SUBDIVIDE THE LOTS SO THAT THE DRIVEWAY OF THE EXISTING BUILDING WOULD BE ON ITS OWN LOT AND THE OTHER TWO LOTS WOULD BE CONSOLIDATED INTO ONE LOT ON WHICH HE PROPOSES TO BUILD A 7 UNIT APARTMENT BUILDING. THE BOARD DISCUSSED THE PARKING LOT, LANDSCAPE PLAN, THE REFUSE AREA, AND REPLACING THE SIDEWALK. MS. REYNOLDS WAS PRESENT TO INQUIRE THE PERCENTAGE OF BUILDING AND PARKING LOT COVERAGE TO THE SIZE OF THE LOT. SHE STATED THAT SHE BELIEVED THE LOT WAS TOO SMALL. SHE WAS TOLD THAT LOT COVERAGE WAS ONE OF THE VARIANCES MR. BORGO REQUESTED.

MOTION BY MARCH, SECONDED BY BOWDEN, TO DIRECT STAFF TO DRAFT AN ORDINANCE TO ACCEPT THE PLANNING/ZONING COMMISSION RECOMMENDATIONS TO APPROVE THE VARIANCES FOR 451 S. WEST STREET OWNED BY MR. BORGO WITH THE PLANNING/ZONING CONDITIONS, THE FINAL LANDSCAPE PLAN, THE FINAL ENGINEERING PLAN, AND THE SIDEWALK IMPROVEMENT. MARCH, BOWDEN, HAMM, AND MAREVKA VOTING AYE; JONES VOTING NO; MOTION CARRIED.
