**PLEDGE OF ALLEGIANCE** 

THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE VILLAGE PRESIDENT, STEVEN CROSS, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MS. MAREVKA, MR. JONES, DR. MARCH, MR. PARKER, MR. HAMM, AND MR. BOWDEN. ALSO PRESENT WERE THE CLERK, ATTORNEY, ENGINEER, MR. IVANOFF, MR. OSMOLSKI, MR. LIVENGOOD, MR. PETERSON, MS. MOORE, MS. HARPIN, AND MR. AMASKANE.

**CALL TO ORDER** 

**ROLL CALL** 

MOTION BY MAREVKA, SECONDED BY MARCH, TO APPROVE THE MINUTES OF THE AUGUST 13, 2018, REGULAR VILLAGE BOARD MEETING AS WRITTEN. MAREVKA, MARCH, PARKER, BOWDEN, AND HAMM VOTING AYE; JONES VOTING PRESENT; MOTION CARRIED.

**MINUTES** 

MOTION BY PARKER, SECONDED BY JONES, TO APPROVE THE PAYROLL AND TO APPROVE THE ACCOUNTS PAYABLE IN ALL CATEGORIZED FUNDS AS PRESENTED. PARKER, JONES, MAREVKA, MARCH, HAMM, AND BOWDEN VOTING AYE; MOTION CARRIED.

PUBLIC COMMENT

ENGINEER REPORT - REGARDING THE STREET PROJECT, THE CONCRETE GRINDING HAS BEEN FINISHED AND THE PAVING SHOULD START TOMORROW.

**REPORTS** 

THE ENGINEER STATED THAT THE DETOUR FOR THE RATHJE ROAD PROJECT WOULD BEGIN SEPTEMBER 7<sup>th</sup>. HOPEFULLY RATHJE ROAD WILL BE FINISHED BY WINTER, BUT IF THAT IS NOT POSSIBLE, THE BINDER WOULD BE PAVED BY WINTER AND THE PROJECT FINISHED IN THE SPRING.

THE UTILITY RELOCATIONS SHOULD BE FINISHED SOON FOR THE RTE. 50 PROJECT.

THE ENGINEER INFORMED THE BOARD THAT THERE IS A CALL FOR 2019 SAFE ROUTES TO SCHOOL PROJECTS. THE BOARD DISCUSSED THE PEOTONE-WILMINGTON ROAD SIDEWALK/BIKE PATH THE PAST VILLAGE BOARDS HAD BEEN DISCUSSING FOR YEARS. A CROSSING LIGHT WAS DISCUSSED FOR PEOTONE-WILMINGTON ROAD IN CONJUNCTION WITH THE SIDEWALK/BIKE PATH. SUBMITTING AN APPLICATION FOR SIDEWALKS CLOSER TO THE ELEMENTARY SCHOOL FOR A BETTER CHANCE OF ATTAINING THE GRANT WAS DISCUSSED. MR. IVANOFF STATED THAT WILMINGTON ROAD WAS SLATED TO BE WIDENED INTO FOUR LANES AND INQUIRED IF THE SIDEWALK/ BIKE PATH WOULD BE RUINED IF THAT HAPPENED. THE ENGINEER STATED THAT IF THE ROAD WAS WIDENED, THE SIDEWALK/BIKE PATH COULD POSSIBLY BE PART OF THEIR PROJECT. THE BOARD WAS SPLIT BETWEEN THE TWO PROJECTS. THE PRESIDENT WOULD REACH OUT TO THE SCHOOL AND FIND OUT WHICH STREETS CLOSE TO THE ELEMENTARY SCHOOL THE CHILDREN USED MOST.
