BOWDEN. ALSO PRESENT WERE THE CLERK, THE INTERIM VILLAGE ADMINISTRATOR, ATTORNEY, AND ENGINEER.

MOTION BY MAREVKA, SECONDED BY HAMM, TO APPROVE THE MINUTES OF THE NOVEMBER 12, 2018, REGULAR VILLAGE BOARD MEETING AS WRITTEN. MAREVKA, HAMM, PARKER, AND MARCH VOTING AYE; JONES AND BOWDEN VOTING PRESENT; MOTION CARRIED.

**DEBT CERT PAYMENT**

THE BOARD DISCUSSED THE OPTIONS OF THE ADDITIONAL FUNDING FOR THE POLICE PENSION NOW OR LATER.

**DPW BUILDING PAYMENT** 

THE BOARD DISCUSSED PAYING OFF THE NEW PUBLIC WORKS BUILDING DEBT TO HOMESTAR BANK IN THE AMOUNT OF \$295,035.55.

MOTION BY MARCH, SECONDED BY MAREVKA, TO APPROVE THE PAYMENT OF \$295,035.55 TO HOMESTAR BANK FOR THE PUBLIC WORKS BUILDING PURCHASE. MARCH, MAREVKA, JONES, PARKER, HAMM, AND BOWDEN VOTING AYE; MOTION CARRIED.

THE BOARD CONTINUED THE DISCUSSION FROM THE LAST MEETING REGARDING THE BLOWING/SHOVELING/ PUSHING OF SNOW/LEAVES/GRASS INTO THE STREETS. A DRAFT OF AN ORDINANCE WAS REVIEWED. THE BOARD DISCUSSED HOW WOULD THE ORDINANCE BE ENFORCED AND WHO WOULD ENFORCE THE ORDINANCE. THE PRESIDENT APPEALED TO THE RESIDENTS TO USE COMMON SENSE AND COOPERATE WITH THE VILLAGE BY NOT PUTTING THE SNOW, LEAVES, AND GRASS INTO THE STREETS.
